Dear Doctor,

We have prepared for you a short overview of the SilentCloud advanced tinnitus management program, as well as detailed instructions on how to fill out the Prescription Form.

You can also provide digital prescriptions via our SilentCloud ENT Dashboard once you have a registered account (visit silentcloud.com for more information).

SilentCloud is a CE marked medical app for self-paced management of bothersome tinnitus.



The approach used by SilentCloud is built on clinical recommendations for successful tinnitus management, including tinnitus assessment tools, established sound therapies, iCBT, counseling and relaxation aids.

Tinnitus Characterization

While on their SilentCloud journey, the patients are invited to complete questionnaires and other assessments among which:

- tinnitus severity with the Tinnitus Handicap Inventory (THI)
- tinnitus self-pitch-matching
- hearing screening

Tinnitus Management

The outcomes of the tinnitus characterization are used to tailor the user's tinnitus management plan. Several modules are available to help the patient take control of their tinnitus. Knowledge is power and "Your Tinnitus Tutor" includes 17 lessons to help the patient understand tinnitus better. "Your Calm Corner" offers a library of sounds and exercises to help the patient tune out tinnitus. Advanced therapies require an ENT prescription and are available in 2 additional modules. In "Your

prescription and are available in 2 additional modules. In "Your Counseling Therapy", 40 self-paced sessions of internet-based **Cognitive Behavioral Therapy (iCBT)** aim at transforming the way the patient thinks about their tinnitus. Existing CBT protocols have been tailored for online-based CBT (iCBT). CBT has been shown to reduce THI by 39%*.



"Your Sound Therapies" includes three different types of **sound therapy – foundational sound** (pink noise), **customized sound** (sound individually adjusted for the patient) and **advanced sound** (a neuromodulation approach for tonal tinnitus).

The patient is advised to use sound therapy at levels just above the hearing threshold and sound therapies are intended to be used for half a year.

We do not recommend using **SilentCloud** in case of an existing severe mental disorder. On the Prescription form, you will find further contraindications (e.g. Morbus Meniere) listed for sound therapy.

(2) Auditory Hallucinations, Symptomatic Hearing Disorders, Meniere's Disease, Brainstem Diseases, Psychiatric Disorders, Other Insufficiently treated Serious Comorbidities (e.g. active infection, malignant cancer, active neurological pathologies), Temporomandibular Joint Disorders, Objective Tinnitus, Visible congenital or traumatic deformity of the ear, History of active drainage from the ear within the previous 90 days, History of sudden or rapidly progressive hearing loss within the previous 90 days, History of semicircular canal dehiscence syndrome Active Cervical Pain, Active Sore Throat
